### **2019 SUMMER FEEDING PROGRAM APPLICATION AVAILABLE**

ST. THOMAS, USVI –The Virgin Islands Department of Education, St. Thomas – St. John District School Food Authority, announces the availability of the 2019 Summer Feeding Program Application.

Summer Feeding Programs Applications for School Sites/Summer Camps and Employment are available at the Office of School Food Authority in Subbase, St. Thomas.

The Summer Feeding Program will operate from **June 17, 2019** through **August 9, 2019**--(7 weeks & 3 days)

**Employment application deadline is Friday, May 31, 2019.**

**Site/Camp application deadline is Friday, June 7, 2019.**

School age children 2 - 18 years can participate in the Summer Feeding Program. A person between ages 19 – 21 who has mental or physical disability (as determined by a State or Local Educational Agency) and who participates during the school year in a public or private non-profit school program (established for the mentally or physically disabled) is also eligible to participate in the Summer Feeding Program.

### **Statement**

In accordance with Federal civil rights law and U.S. Department of Agriculture (USDA) civil rights regulations and policies, the USDA, its Agencies, offices, and employees, and institutions participating in or administering USDA programs are prohibited from discriminating based on
