Dear Parent/Guardian,

Your child _____ is a proud senior at St. Croix Central High School. As a senior, we believe he/she should have certain privileges that supersedes those of the underclassmen. Therefore, the administration has decided to allow our seniors to park on campus and allow those who have on the job training (OJT) to use their vehicles as well. Parents and seniors, please note that all monies collected as part of the parking privilege will be part of the fundraising efforts for the graduating class of 2024. These are the rules that each student assigned a parking permit must follow.

- Each applicant will pay \$30.00 to park their vehicle in a designated area on CHS campus.
- Student drivers must drive a registered vehicle and must submit proof of registration and vehicle insurance (with student's name visible) on vehicle insurance.
- All monies and documents must be submitted to Ms. Carroll in the main office prior to parking on campus.
- Student drivers will receive a parking permit and must conspicuously place their permit in the front window of their vehicle.
- Student drivers must sign in and out when arriving and leaving campus.
- Student drivers are not allowed to leave for personal reasons without a signed note from a parent.
- Student drivers must adhere to the speed limit and noise level mandates.
- Student vehicles are subject to random searches.

Failure to comply with these rules will result in privileges being revoked as well as the customary disciplinary actions being imposed. We will not be responsible for your child's car if the following occurs:

1. Student car is damaged or vandalized while on campus.
2. Student car is damaged as a result of other students driving/riding in your child's vehicle.
3. Your child gets in an accident on or off campus.

By signing this form, you acknowledge and agree to the above. We encourage you to have a serious conversation with your child concerning the safety issues and responsibilities involved with having his/her own vehicle. Please sign and return the permission slip below which gives your consent for your child to drive their vehicle on campus, as well as also leave campus to attend class at CTEC and/or (OJT) On-the-Job-Training.
